THIS PERMIT SHALL REMAIN IN FORCE AND EFFECT PENDING THE DIRECTOR'S FINAL DETERMINATION ON THE PERMITTEE'S APPLICATION, BUT IN NO EVENT BEYOND THE EXPIRATION DATE STATED ABOVE.

THIS PERMIT IS EXPRESSLY CONDITIONED THAT THE PERMITTEE SHALL NOT SELL, SERVE, DELIVER OR ALLOW, PERMIT OR SUFFER THE SALE, SERVICE OR DELIVERY OF ANY ALCOHOLIC BEVERAGE, DIRECTLY OR INDIRECTLY TO ANY PERSON UNDER THE LEGAL AGE TO CONSUME ALCOHOLIC BEVERAGES, NOR TO ANY PERSON WHO IS ACTUALLY OR APPARENTLY INTOXICATED. THE PERMITTEE HEREBY CONFFERS UPON THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL AND HIS INVESTIGATORS, AUTHORITY TO INSPECT AND SEARCH, WITHOUT WARRANT, AT ANY TIME, THE PREMISES MENTIONED ABOVE.

THIS PERMIT IS EXPRESSLY SUBJECT TO ALL LIMITATIONS AND CONDITIONS HEREIN SET FORTH OR HERAFTER IMPOSED, AND TO ALL RULES AND REGULATIONS PROMULGATED HERETOFORE AND HERAFTER BY THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL. THIS PERMIT MAY BE CANCELED OR AMENDED BY THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL IN HER SOUND DISCRETION AT ANY TIME WITHOUT NOTICE, REASON OR CAUSE.

STARTING ON JANUARY 1, 2026, A \$150 QUARTERLY RENEWAL FEE WILL BE CHARGED. THIS TAP WILL BE SUBJECT TO RENEWAL ON A QUARTERLY BASIS (MARCH 31ST, JUNE 30TH, SEPTEMBER 30TH, AND DECEMBER 31ST) AND A \$150 FEE WILL BE ASSESSED AT EACH OF THE RENEWALS. A PERMITTEE'S FAILURE TO PAY THE FEE WILL RESULT IN THE EXPIRATION OF THE TAP.

- 1 - TEMPORARY AUTHORIZATION PERMIT TO OPERATE ISSUED PURSUANT TO N.J.S.A. 33:1-74, SUBJECT TO ALL STATUTES AND REGULATIONS AND THE WITHIN TERMS AND CONDITIONS, TO AUTHORIZE EAST COAST WAREHOUSE & DISTRIBUTION CORP. ("EAST COAST WAREHOUSE"), TO RECEIVE FOR PURPOSES OF STORING AND WAREHOUSING AND TO STORE AND WAREHOUSE ALCOHOLIC BEVERAGES WITHIN ITS LICENSED PUBLIC WAREHOUSE, AT 20 SIGLE LANE, SOUTH BRUNSWICK, NEW JERSEY, 08810, AS DEPICTED ON THE PROVIDED SKETCH, PURSUANT TO N.J.S.A. 33:1-14.
- 2 - ALL EMPLOYEES OF EAST COAST WAREHOUSE MUST BE UNDER THE DIRECT SUPERVISION AND CONTROL OF EAST COAST WAREHOUSE, AND LISTED ON THE REQUIRED EMPLOYEE LIST (E141). THE EMPLOYEE LIST (E141) MUST BE READILY AVAILABLE FOR REVIEW UPON REQUEST BY THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL.
- 3 - EAST COAST WAREHOUSE IS NOT AUTHORIZED TO STORE AND WAREHOUSE ALCOHOLIC BEVERAGES ON BEHALF OF A PUBLIC RELATIONS FIRM, WITHIN ITS LICENSED PUBLIC WAREHOUSE AT 20 SIGLE LANE, SOUTH BRUNSWICK, NEW JERSEY, 08810.
- 4 - EAST COAST WAREHOUSE IS AUTHORIZED TO STORE AND WAREHOUSE ALCOHOL ON BEHALF OF PRIVATE COLLECTORS, IMPORTERS, EXPORTERS, WHOLESALERS, RETAILERS, AND AUCTION HOUSES, WITHIN ITS LICENSED PUBLIC WAREHOUSE AT 20 SIGLE LANE, SOUTH BRUNSWICK, NEW JERSEY, 08810.

- 8 - ALCOHOL STORED FOR AN AUCTION HOUSE BY EAST COAST WAREHOUSE WITHIN ITS LICENSED PUBLIC WAREHOUSE AT 20 SIGLE LANE, SOUTH BRUNSWICK, NEW JERSEY, 08810, WILL ONLY BE DELIVERED TO POINTS OUTSIDE OF NEW JERSEY, SUBJECT TO THE AUTHORITY OF THAT DESIGNATED STATE.
- 9 - ALCOHOL STORED FOR AN OUT-OF-STATE IMPORTER, EXPORTER, OR WHOLESALER, BY EAST COAST WAREHOUSE WITHIN ITS LICENSED PUBLIC WAREHOUSE AT 20 SIGLE LANE, SOUTH BRUNSWICK, NEW JERSEY, 08810, WILL ONLY BE DELIVERED TO POINTS OUTSIDE OF THE STATE OF NEW JERSEY, SUBJECT TO THE AUTHORITY OF THAT DESIGNATED STATE.
